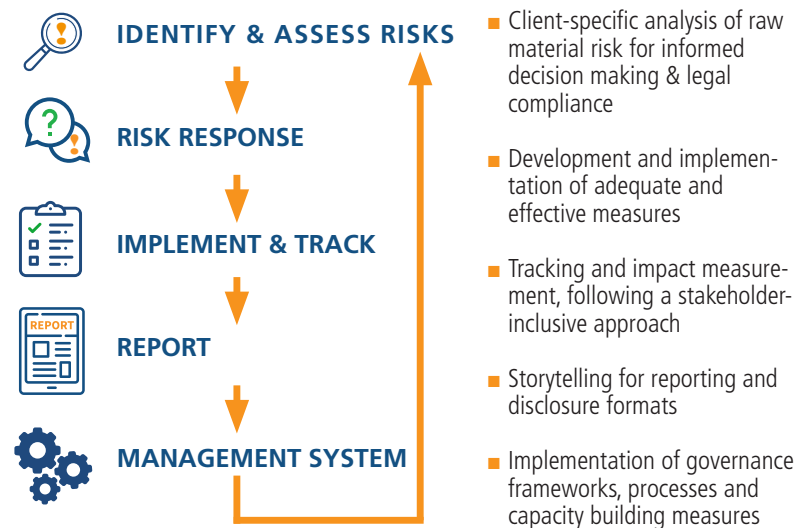

BETTER GOLD INITIATIVE (BGI)

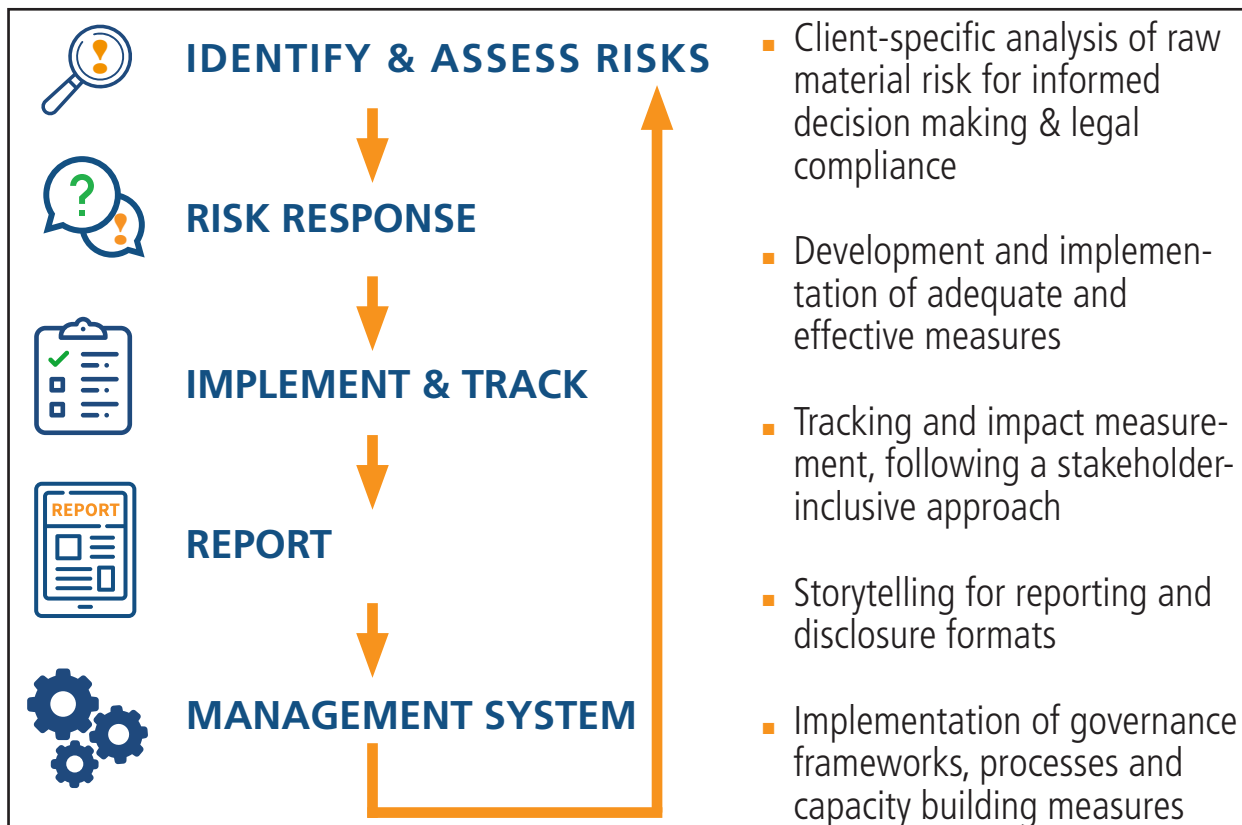
